Jan \$36 Social is for Easter Egg candy

Jan \$1,000 Accounting was transferred to Centennial to open Autumn Ridge bank accounts

Feb -\$1,000 Accounting shows the return of money transferred from Tiehen to Centennial to open bank accounts

Feb \$189 Misc was to purchase Autumn Ridge blank checks that are compatible with Centennial's laser printer

Mar \$110 Legal was for KS Annual Report and change of registered agent

Mar \$703 Postage was for mailing violation notices, new mgmt company introduction, Annual Meeting and voting ballots
