Johnson County Homeowner Security Camera Registry Project:

Mike Lane Introduced representatives from the Johnson County Sheriff's Department Deputy Johnson and Lieutenant Denton.

- Deputy Johnson and Lieutenant Denton gave an overview and led a discussion regarding a
 partnership program for community members who have home surveillance cameras, such as
 video doorbells, to potentially provide images or footage to support criminal investigations.
- Residents with surveillance cameras, video doorbells, or similar fixtures, will have the ability to
 register with the county, providing their information as well as some basic information about their
 security equipment.
 - O Supplying personal and surveillance equipment information will not allow the sheriff to remotely connect or otherwise obtain images or footage from homeowners without physically visiting homes.
 - O Through this registry, the Sheriff can identify residents whose cameras may have images or footage which can assist in criminal investigations.
 - O A link to a website allowing residents to register will available later this month and will

be posted when available, expected to be available October 22nd.

- Homeowners whose equipment has been identified as potentially being able to assist in an
 investigation will be contacted by the Sheriff to review and provide images or footage if
 applicable.
- Residents have been approached in the past through an informal registry and have been helpful in assisting investigations, following this informal trial program the Johnson County Sheriff's department is formalizing and planning to expand this program.
- River Ridge Farms is a pilot community for this new partnership program planned for expansion throughout Johnson County.
