That Developer assumes and agrees to perform any and all obligations pertaining to the rights, powers and casements of the Declaration binding Duggan Land Development, Inc., and Duggan Land Development, Inc. is hereby released and relieved from all liability with respect to such obligations accruing from and after the date of the recording of this Supplement.
