The undersigned natural persons, for the purpose of forming a corporation under the Missouri Nonprofit Corporation Act, R.S.Mo. Section 355.001 *et seq.*, adopts the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation (which is hereinafter referred to as the "Corporation") is: Tiffany Greens Community Association, Inc.

The Corporation is a homeowner and community improvement association.

The period of duration for the Corporation is perpetual.
