Pool Rules

- The swimming pool facilities will be available for enjoyment and use by association members in good standing and their guests during the following hours: Everyone daily 9:00am - 9:00pm. Adults until 10:00pm.
- 2. NO LIFEGUARD OR ATTENDANT ON DUTY. SWIM AT YOUR OWN RISK.
- 3. NO CHILDREN UNDER AGE 14 WITHOUT AN ADULT IN ATTENDANCE. Children under 14 years of age must be supervised by their parent or other adult guardian (18 years or older). Parents or guardians are expected to supervise their children and shall be responsible for and accountable for the actions of their children and their guest(s).
- 4. CHEWING GUM IS NOT ALLOWED INSIDE THE SWIMMING POOL SECURITY FENCE.
- 5. SMOKING/VAPING IS NOT ALLOWED ANYWHERE IN THE SWIMMING POOL FACILITIES PROPERTY!
- 6. NO RUNNING, GLASS CONTAINERS, METAL TOYS, BICYCLES, TRICYCLES, SKATE BOARDS, ROLLER BLADES OR PETS ALLOWED INSIDE THE FENCED POOL AREAS.
- 7. NO DIVING FROM THE EDGE OF THE POOL, OR FROM POOL LADDERS. THE POOLS ARE NOT DESIGNED TO ACCOMMODATE DIVING. ALL TYPES OF SOMERSAULTS, CANNONBALLS, PREACHER SEATS, CAN OPENERS, ETC. ARE PROHIBITED FROM THE EDGE OF THE POOLS. GYMNASTICS IN THE POOLS, ON OR FROM THE LADDERS OR ON THE POOLS CONCRETE DECKS IS PROHIBITED.
- 8. BOISTEROUS PLAY, ROUGHNESS, OR GAMES ENDANGERING SWIMMERS, SUNBATHERS, OR SPECTATORS IS PROHIBITED. Inflatable vinyl beach balls not exceeding 24" in diameter are permissible. All other types and sizes of balls are prohibited.
- 9. FACE MASKS full vision swimming face masks shall have safety tempered glass.
- 10. ONLY SWIMMING SUITS ALLOWED no other types of clothing shall be worn as swimming attire

in either swimming pool. No t-shirts, unless for medical, personal hygiene, or health reasons for which the allowed t-shirt shall be plain white. NORMAL CLOTHING SUCH AS SWEAT SHIRTS, BUTTON SHIRTS, TANK TOPS, CUT OFF CLOTHES, SHORTS, JEANS, ETC. ARE NOT TO BE WORN IN EITHER POOL.

Fontainebleau

- ALL INFANTS shall wear appropriate swimming suits AND plastic pants. NO DISPOSABLE DIAPERS WILL BE ALLOWED in either swimming pool for sanitary purposes except for the new "swim diapers" which are permissible and their use is encouraged.
- 12. NO ELECTRICAL DEVICES (other than battery operated) are allowed inside the enclosed fenced pool areas.
- 13. MUSIC The volume of portable musical devices shall be kept low enough to not disturb other pool users. When patrons with musical devices are out of the pools sunbathing, resting, etc. the use of ear phones would be appreciated and encouraged.
- 14. SUNTAN OIL OR BABY OIL used by swimmers is not permitted. Suntan oils clog the pool filters and coats the pool sides and concrete decks, making them a slip hazard. Water soluble suntan lotions or sun blocks are permissible.
- 15. THE POOL ENTRANCE GATE shall be closed and locked after entering or leaving the enclosed pool areas. This is essential and very important! Do not open the entrance gate for strangers!
- 16. CHILDREN'S WADING POOL is intended for young children only.No child shall be left unattended and must be under adult supervision at all times.
- 17. RESTRICTING OR IMPEDING CIRCULATING WATER FLOW - do not place hands, feet or body over the circulating pool water discharge nozzles located in the side walls of the pools. Doing so restricts the normal circulating water flow and causes excess water back-pressure on the water circulating pumps and pool filtration equipment thus "upsetting" the equipment's normal function and operation.

- POOL FURNITURE AND EQUIPMENT shall be treated with respect, not abused and used as intended by the manufacturer, and never put into the pool. Furniture is first come first serve, no reserving allowed.
- 19. NO ABUSIVE OR PROFANE LANGUAGE will be allowed or tolerated anywhere on the swimming pool facilities property under any circumstances!
- 20. NO INTOXICATED PERSONS will be allowed or tolerated anywhere on the swimming pool facilities property.
- 21. POOL PRIVILEGES Only Fontainebleau Homes Association families in "good standing" and who have returned their completed Acknowledgement and Release Form to the homes association, have the right to use these swimming pool facilities. It is understood that these facilities are for the private use of Fontainebleau Homes Association residents and their guests. All other unauthorized persons attempting to use or actually using the pool facilities will be considered trespassing and subject to prosecution to the fullest extent allowable by law.
- 22. THUNDERSTORMS/INCLEMENT WEATHER -Patrons should be very aware and alert towards possible sudden weather changes. Whenever the threat of lightning and/or other types of possible hazardous weather is likely, the swimming pool facilities shall be considered "closed" and patrons shall leave the swimming pool facilities premises until acceptable swimming weather returns. Umbrellas should be lowered before departing.

23. GUEST POLICY - All guests must be accompanied by an adult association member at all times. While there is no limit to the number of guests, please be respectful and keep guests to a minimum, especially during busy times like evenings and weekends.

- 24. CLEAN UP As a courtesy to all, everyone is requested to leave the pool areas in a clean and orderly condition for others to enjoy. Everyone please be responsible for your own cleanup. Trash and recycling receptacles are provided for your use and convenience. If you relocate pool furniture, please return the furniture to its normal place when you leave to help keep the pool appearance neat and orderly.
- 25. VIOLATIONS of these Rules and Regulations may result in the suspension of an association member's family swimming pool privileges for a designated period of time. There will be no consideration or allowances for any reduction or refund of violator's association annual assessments during any suspension.
- 26. ENFORCEMENT All Fontainebleau Homes Association members shall have the authority to enforce these Rules and Regulations as it is your pool facilities. Any patron who sees a violation occurring should discuss this with the violator. If the violator is not cooperative and/or the violation continues, then the violation should be reported immediately to the Director of Pool Operations or any other board member in text or email form. Recommendations on each received complaint will be submitted to the homes association board of directors for their consideration, final action and written response.

These Rules and Regulations are subject to change at any time upon the approval from the Fontainebleau Homes Association Board of Directors. Association members will be notified of any rules and regulation changes through notices posted on eNeighbors. Exceptions to these Rules and Regulations may be made during homes association sponsored events.

THANK YOU FOR YOUR COOPERATION. It is the association's goal to provide a fun, safe, healthy and financially viable environment which responds to the needs of its members. This goal can be met if everyone follows these rules and regulations, but just as important, extends courtesies and respects the rights of others.
