

THE WILSHIRE HOA

WCA/GFL WASTE SERVICES INFORMATION SHEET

The Wilshire refuse is collected every Tuesday by WCA/GFL Environmental. Each solid waste cart should be placed at curbside for collection no later than 7am and positioned as close to the roadway as practicable without interfering or endangering the movement of vehicles or pedestrians.

RECYCLING

Recycled items should be placed in the WCA/GFL provided 65 gallon recycling card and overflow can be placed adjacent to the cart in boxes or rigid containers. Note: Bagged recyclables will not be collected.

Acceptable items include newspaper, magazines, phone books, catalogs, junk mail, envelopes, file folders, computer paper, construction paper, colored paper, flattened corrugated cardboard boxes, cereal and soda/beer boxes, gift boxes, and wrapping paper. Containers including aluminum cans, aluminum foil, plastic bottles, jugs, metal cans, buckets and other plastic containers (#1 through #7).

WCA/GFL will not accept Glass, Plastic Bags, or Styrofoam.

YARD WASTE

WCA will collect up to 10 properly prepared bags and/or bundles of residentially generated yard waste from each household once each week, 52 weeks a year.

Acceptable items include Yard waste will consist of grass clippings, leaves and loose vegetation, small limbs, and branches. Yard waste must be placed in biodegradable paper bags; or a plastic bin no more than 32 gallons; or bundled and neatly placed at the curb for collection. Limbs and branches cannot be larger than 18 inches in diameter, four feet in length, and must be tied in a bundle with twine. This includes Christmas trees that have been cut into sections no more than 4 feet in length (all decorations/lights must be removed). All items must be 40 pounds or less in weight.

WCA/GFL will not accept Items placed in plastic bags, Wood Fencing, landscape timbers, flowerpots, yard decorations, mulch, rock, dirt, and similar items.

BULKY ITEM COLLECTION

Bulky Item Collection will occur on the first (1st) Tuesday of each month. WCA/GFL will collect one large item per month from all eligible Association households.

Acceptable items include such household items as that can be readily moved by two people, including mattresses, couches, box springs, chairs, dressers, desks, doors, windows and other household furniture. Items are to be placed within 6 feet of the curb no later than 7 a.m. on the day of collection.

WCA/GFL will not accept computers, monitors and other electronics waste, appliances, hazardous waste, tires, automotive parts and construction materials. Hot water heaters are considered an appliance.

HOLIDAY SCHEDULE

If your scheduled collection day falls on any of the following holidays the normal service will be resumed the following scheduled pick-up day. Holidays are: New Year's Day, Thanksgiving Day, and Christmas Day.
