## DECLARATION OF RESTRICTIONS AND HOME OWNERS' ASSOCIATION DECLARATION

THIS DECLARATION, made as of the <u>A7</u> day of <u>Tune</u>, 2013, by the Declarant, JMK PARTNERS, L.L.C., a Kansas limited liability company.

## WITNESSETH:

WHEREAS, the Declarant has executed and filed with the Register of Deeds of Leavenworth County, Kansas, a **3rd Plat** of the subdivision known as "**ROCK CREEK RIDGE**", which plat was recorded on June 11, 2013, at Document No. 2013R00011; and

WHEREAS, such plat adds the following lots to the subdivision **ROCK CREEK ESTATES**, to-wit:

Lots 176 through 206, inclusive, **ROCK CREEK RIDGE, 3RD PLAT**, a subdivision in the City of Lansing, Leavenworth County, Kansas, according to the recorded plat thereof;

and

WHEREAS, the Declarant, as the owner of the foregoing lots ("Additional Lots") desires to subject the Additional Lots to the covenants, restrictions, easements and other provisions contained in that certain Declaration of Restrictions, dated as of September 26, 2000 (the "Original Declaration"), executed Declarant and filed with the Register of Deeds of Leavenworth County on September 27, 2000 and recorded in Book 0796 at Page 0245, and in that certain Homes Association Declaration dated as of September 26, 2000 (the "Original Homes Association Declaration"), executed by Declarant and filed with the Register of Deeds of Leavenworth County, Kansas on September 27, 2000 and recorded in Book 0796, at Page 0253.

As contemplated in the Original Declaration and Original Homes Association Declaration, this instrument shall have the effect of subjecting the Additional Lots to all of the provisions of the Original Declaration and Original Homes Association Declaration as though the Additional Lots had been originally described therein and subjected to the provisions thereof.
