THIRD AMENDMENT TO AMENDED AND RESTATED DECLARATION OF RESTRICTIONS AND SUBMISSION TO TOWNHOME OWNERSHIP UNDER SECTION 58-3700 ET. SEQ., KANSAS STATUTES ANNOTATED FOR ENCLAVE AT THE RESERVE TOWNHOMES

THIS THIRD AMENDMENT TO AMENDED AND RESTATED DECLARATION, is made as of the 33rd day of September, 2015, by the Board of Trustees ("Board") of the Reserve 8th Plat Homes Association, a Kansas not-for-profit corporation ("Association") and the undersigned ("Owners").

WITNESSETH:

WHEREAS, Reserve Townhomes, LLC ("Original Developer") executed that certain Amended and Restated Declaration of Restrictions and Submission to Townhome Ownership Under Section 58-3700 et seq., Kansas Statutes Annotated for Enclave at the Reserve Townhomes dated September 29, 2010 and recorded in the office of the Register of Deeds of Johnson County, Kansas on September 29, 2010 at Book 201009, Page 011713, as amended on April 20, 2012 and recorded in the office of the Register of Deeds of Johnson County, Kansas on April 20, 2012, at Book 201204, Page 007544; (collectively, the "Original Declaration"); and

WHEREAS, the Original Declaration encumbers the real property legally described on Exhibit "1" attached hereto; and

WHEREAS, the Original Declaration provides that the same can be amended with the approval of the Board by two-thirds of the owners within the "Townhome Sub-Group" (as defined in the Original Declaration); and

WHEREAS, the undersigned Owners represent over two-thirds of the Townhome Sub-Group; and

WHEREAS, it is unclear whether certain real property is encumbered with or by the Original Declaration, and it is necessary to clarify same to exclude such real property; and

WHEREAS, the Board and Owners wish to amend the Original Declaration to redefine the composition of the Board (as defined in the Original Declaration) and combine it with the board of directors having jurisdiction over the community known as the Enclave at the Reserve Condominiums.

NOW, THEREFORE, in consideration of the premises, the Board and Owners hereby declare for themselves and their heirs, executors and assigns and for their future grantees:

- 1. That the real property described on Exhibit "2" ("Removed Property") be and is hereby removed and excluded from the Original Declaration, and shall be considered as never having been encumbered by the Original Declaration, if in fact it was ever so encumbered.
- 2. Paragraph 3.1, <u>Composition of the Board</u>, is hereby deleted and replaced in its entirety with the following new Paragraph 3.1:

Paragraph 3.1, Composition of the Board.

The Board shall be composed of and represent the members of the Association. The Board of Trustees shall be composed of five persons and shall represent both the Townhome Unit Owners and the Condominium Unit Owners. There shall be two (2) members elected by the Townhome Sub-Group, two (2) members elected by the Condominium Sub-Group and one (1) member elected at large by the collective members of the Association. Initially, three (3) members of the Board shall be elected to three (3) year terms and two (2) members shall be elected to two (2) year terms; thereafter, all members shall serve two (2) year terms.

3. Paragraph 3.2, <u>Sub Boards</u>, is hereby deleted and replaced in its entirety with the following new Paragraph 3.2:

3.2 Committees.

The Board may establish such committees as it deems appropriate, however the Board shall establish a Townhome Committee and Condominium Committee to consider and deal with matters specific to the Townhomes and Condominiums, respectively. The committees shall be comprised of at least three (3) Townhome Unit Owners (Townhome Committee) and at least three (3) Condominium Owners (Condominium Committee). The terms of appointment, duties and responsibilities for all committees shall be determined by the Board.

- 4. Article 4 of the Original Declaration is hereby stricken.
- 5. All references to Sub Boards and the functions, powers and duties thereof are hereby stricken from the Original Declaration.
