AMENDMENT TO AMENDED AND RESTATED DECLARATION OF COVENANTS, RESTRICTIONS, ASSESSMENTS AND EASEMENTS

THIS DECLARATION, made as of the 27 day of June, 2016, by **DAROL RODROCK HOMES, LLC**, a Kansas limited liability company ("Declarant").

WITNESSETH:

WHEREAS, Reveda of Overland Park, Inc., a Kansas corporation, Declarant's predecessor-in-interest, executed that certain Declaration of Covenants, Restrictions, Assessments and Easements of Cottages at Woodridge, which were recorded in the office of the Johnson County, Kansas Register of Deeds on February 20, 2007 at Book 200702, Page 005893, as amended and restated in its entirety by the Amended and Restated Declaration of Covenants, Restrictions, Assessments and Easements of Cottages at Woodridge recorded on March 24, 2008, at Book 200803, Page 007244 (as so amended and restated, the "Declaration"); and

WHEREAS, Declarant is the successor in interest to Reveda of Overland Park, Inc. by virtue of a written assignment of developer rights; and

WHEREAS, the Declarant has executed and filed with the Register of Deeds of Johnson County, Kansas, a 4th Plat of the subdivision known as "Cottages at Woodridge", which plat was recorded on ________, 2016, in Book ________ at Page

WHEREAS, such plat adds the following lots to the community of Cottages at Woodridge, to-wit:

Lots 31 through 35, inclusive and Tract E, COTTAGES AT WOODRIDGE, 4th PLAT, a subdivision in the City of Overland Park, Johnson County, Kansas, according to the recorded plat thereof;

and

WHEREAS, the Declarant has executed and filed with the Register of Deeds of Johnson County, Kansas, a 5th Plat of the subdivision known as "Cottages at Woodridge", which plat was recorded on _______, 2016, in Book _______, at Page _______, at Page

WHEREAS, such plat adds the following lots to the community of Cottages at Woodridge, to-wit:

Lots 36 through 40, inclusive and Tract F, COTTAGES AT WOODRIDGE, 5th PLAT, a subdivision in the City of Overland Park, Johnson County, Kansas, according to the recorded plat thereof;

and

WHEREAS, the Declarant desires to subject all of the above property (the "Additional Lots") to the covenants, restrictions, easements and other provisions contained in the Declaration.

NOW, THEREFORE, in consideration of the premises, Declarant, for itself, and for its successors and assigns, and for its future grantees, hereby agrees and declares that all of the Additional Lots shall be, and they hereby are, subject to the covenants, restrictions, easements and other provisions set forth in the Declaration. As contemplated in the Declaration, this instrument shall have the effect of subjecting the Additional Lots to all of the provisions of the Declaration as though the Additional Lots had been originally described therein and subjected to the provisions thereof.
