CONTRACT AND AGREEMENT FOR THE USE OF THE CLUBHOUSE FACILITIES

This Agreement made and entered into this ____ day of _____, 20__ by and between Terrybrook Farms Homes Association, Inc.,

Herein after referred to as Owner, and _____, hereinafter referred to as User.

WITNESSETH: That User shall be provided the use of Terrybrook Farms Clubhouse facilities, hereinafter referred to as facilities, under the following terms and conditions and that the swimming pool is not included in the term “facilities.”

4	A non-refundable user fee of \$300 (\$260+ \$40 processing fee) is required for all rentals at the time of reservation. A security deposit of \$250.00 shall be paid at the time of reservation. Separate checks for the user fee and security deposit are preferred. Send a check or money order payable to Terrybrook Farms HOA.	
5	The user fee of \$300 will be forfeited if reservation is not cancelled within 14 days of the engagement date. <u>The reservation will be accepted upon receipt of this signed contract.</u>	
6	Upon a satisfactory inspection, the \$250 deposit will be <u>voided and destroyed</u> . (As long as there are no damages that would require the deposit to be processed.)

User must be present at the event from start to finish including the decorating and clean up. User agrees to pay, in full, the amount of such damage, and further agrees that if such payment is not made in a timely fashion, such payment will be charged to use as a Homeowners Assessment. 20	Clubhouse furniture may not be taken outside or removed from the building. This also includes taking the furniture on to the deck or concrete. If furniture is moved inside, it must be returned to original location. Trash space is limited at the facility. <u>ALL full trash bags trash must be returned to the home of the Renter.</u>	Initial/Sign _____
